

Hold Harmless Agreement, Release and Waiver of Liability for Minor



This Hold Harmless Agreement, Release and Waiver of Liability (the "Release") executed on _____ (DATE), by _____ (the Parent or Guardian of the "Child" of "Participant") in favor of HappyBottoms, their directors, officers, employees, and agents (collectively "HappyBottoms "). The undersigned, parent or guardian of _____, (the "Participant") hereby freely, voluntarily, and without duress executes this Release under the following terms:

RELEASE AND WAIVER: The Parent or Guardian does hereby release and forever discharge and hold harmless HappyBottoms and its successors and assigns from any and all liability, claims and demands of whatever kind or nature either in law or in equity, which arise or may hereafter arise from Participant's activities with HappyBottoms. Parent or Guardian understands that this Release discharges HappyBottoms from any liability or claim that the Participant may have against HappyBottoms with respect to any bodily injury, personal injury, illness, death, or property damage that may result from Participant's activities with HappyBottoms, whether caused by negligence of HappyBottoms, or its officers, directors, employees, or agents or otherwise. Parent or Guardian also understands that Happybottoms does not assume any responsibility for or obligation to provide financial assistance or other assistance, including but not limited to medical, health or disability insurance in the event of injury or illness.

MEDICAL TREATMENT: Parent or Guardian does hereby release and forever discharge HappyBottoms from any claim whatsoever which arises or may hereafter arise on account of any first aid, treatment, or service rendered in connection with the Child's participation in the Event.

INSURANCE: Parent or Guardian understands that, except as otherwise agreed to by HappyBottoms in writing; HappyBottoms does not carry or maintain health, medical, or disability insurance coverage for any Participant. Each Participant is expected and encouraged to obtain his or her own medical or health insurance coverage.

MEDIA: I am aware and consent that the below named Participant may appear in a photograph or video taken by HappyBottoms staff or local media and that the photograph or video may appear in a variety of media sources on behalf of HappyBottoms.

OTHER: Parent or Guardian expressly agrees that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Missouri (the location of the Event) and that this Release shall be governed by and interpreted in accordance with the laws of the State of Missouri. Parent or Guardian agrees that in the event that any clause or provision of the Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release which shall continue to be enforceable

The undersigned further declares and represents that no promises, inducements or agreement not herein expressed have been made, that this Hold Harmless Agreement, Waiver and Release contains the entire agreement between the parties, and that this Hold Harmless Agreement, Waiver and Release shall be binding on the undersigned and his or her estate, heirs, executors, personal representatives, successors and assigns.
