The Farmer's House Release and Waiver Form for a Volunteer

NOTICE: By signing this Farmer's House Release Form for a Volunteer (the "Agreement"), you (the "Volunteer") waive certain legal rights, including the right to sue. In consideration for being allowed to participate in The Farmer's House volunteer programs ("The Farmer's House programs"), you agree as follows:

- 1) The Volunteer has read The Farmer's House Volunteer Handbook and will follow all of the rules and will stay within the defined premises of The Farmer's House programs.
- 2) The Volunteer understands that the relationship between The Farmer's House and the Volunteer is an "at will" **VOLUNTEER** arrangement that may be terminated at any time without cause and for any reason by either the Volunteer or The Farmer's House.
- 3) The Volunteer authorizes The Farmer's House, at its discretion, to periodically access, review and obtain copies of state and federal criminal history records of the Volunteer and to make any reasonable efforts to determine whether the Volunteer has been convicted of, found guilty of, or pled guilty to committing, attempting to commit or conspiring to commit, any crime that may bear on the Volunteer's fitness to be a volunteer. The Volunteer further acknowledges that the Volunteer will necessarily be placed in a position of trust over individuals with disabilities and the Volunteer hereby conveys the determination of the Volunteer's fitness solely to The Farmer's House. The Volunteer further agrees to release and hold harmless The Farmer's House, including its affiliates, board of directors, employees, agents, volunteers, participants, and successors-in interest (collectively, "Released Parties"), from any and all claims, demands and/or causes of action which the Volunteer may now or may ever have by reason of or on account of authorizing the release of, accessing, obtaining copies of and/or furnishing such information to The Farmer's House.
- 3) The Volunteer agrees and understands that in the course of volunteering for The Farmer's House programs the Volunteer may be dealing with confidential information and the Volunteer agree to keep any and all such information confidential.
- 4) The Farmer's House has the Volunteer's permission (both during and any time after) to use the Volunteer's likeness, name, voice, or words in either television, radio, film, newspapers, magazines and other media in other form for the purposes of advertising or communicating the purposes and activities of The Farmer's House and/or applying for funds to support those purposes.
- 5) To waive all claims that the Volunteer may have against the Released Parties, arising out of the Volunteer's participation in The Farmer's House programs, expressly including any claims arising from any negligent acts or conduct of the Released Parties.
- 6) To assume all risks of volunteering for and participating in The Farmer's House programs, even those caused by the negligent acts or conduct of the Released Parties, whether foreseen or unforeseen, and including serious physical injury and/or death and other personal and property damage.
- 7) To release the Released Parties from all liability for any loss, damage, injury, death, or expense that the Volunteer may suffer, arising out of the Volunteer's participation in The Farmer's House programs, even those caused by the negligent acts or conduct of the Release Parties.
- 8) To indemnify the Released Parties from all liability for any loss, damage, injury, death, or expense that the Volunteer may suffer, arising out of participation in The Farmer's House programs, even those caused by negligent acts or conduct of the Released Parties.
- 9) To submit any legal dispute arising from The Farmer's House programs to **BINDING ARBITRATION**. Each party shall pay its own costs. Arbitration shall be commenced within one (1) year after the date on which any alleged claim first arose. The arbitration proceeding shall proceed exclusively in Kansas City, Missouri and pursuant to the Federal Arbitration Act. To the extent the Federal Arbitration Act is inapplicable, Missouri law, and specifically the Missouri Uniform Arbitration Act, RSMo. §§435.350 *et seq.* shall apply.
- 10) The Volunteer understands it is the Volunteer's responsibility to notify The Farmer's House of any change of information provided in the Volunteer's application during the time the Volunteer serves as a volunteer at The Farmer's House.
- 11) **I HAVE READ AND UNDERSTAND THIS AGREEMENT AND I AM AWARE THAT BY SIGNING THIS AGREEMENT I MAY BE WAIVING CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE. I FURTHER CERTIFY THAT I AGREE TO THE ABOVE PROVISIONS.**
