

SME Junior Board 2023-24

Why: Jr. Board is the best way for students to learn about a local nonprofit of their choice and make a difference with a team. It gives participants the opportunity to award nonprofits grants simply by giving a presentation.

What: Study a local nonprofit organization and create a presentation for a panel of judges to compete for a grant to award to your selected nonprofit (*grant values vary based on team place*).

Who: You and your team of up to 6 students total. Yes, it can be you and your friends! If you would like to participate but don't have a team, please let the Jr. Board Executives know, and they will place you on a team.

When: Each Jr. Board team will study their selected nonprofit on their own schedule, planning their own team meetings in order to meet each deadline up until the final presentation. Unlike Jr. Board at Indian Hills, we do not meet every week — however, visits to organizations to meet and collect information, volunteer, etc. and meetings to plan presentations will be organized by individual teams on their own time and with their own transportation. Throughout the year, there are a few mandatory meetings, where at least two members from each team are required to attend. see specific dates below. The purpose of these meetings is for Execs to check in on groups and help with presentations along the way.

 - o Deadline for all work (content completed) by **March 7th**
 - o Mandatory rehearsal is week of **March 27**
 - o Final presentations are scheduled for **the first week of April**
